Information regarding VAT:

2.1 WITHDRAWAL CANCELATION

Only effective and complete withdrawals will be eligible for a refund of the registration fee, provided the organizer is informed by November 7, 2025. An administration fee of €50 will always be deducted.

After this date, no refunds will be made for any reason, including force majeure.

Only exception: death of a first-degree relative with supporting documents.

Cancellation of the "Monte Gordo Sand Experience" for any reason, without exception:

- Changes to the opinions of police authorities or others who have authority over the evidence in question.
- Political unrest
- Financial difficulties of the Organizers
- Weather conditions that prevent the organization of the event are considered as force majeure.

In such cases, the organizer is not responsible for refunds or compensation of any kind.

5 ACCREDITATIONS, ADMINISTRATIVE AND TECHNICAL CONTROL

The following documents will be requested for administrative checks:

- Competitor identification document
- Sports license compatible with the race (except Hobby, filling out the waiver)
- National licenses from the countries of origin of the participants (national license from the countries + start permission, which allows repatriation).
- Hobby (acquisition of FMP insurance) Only Portuguese pilots

To classify in any FIM classifications, only valid FIM licenses for the event count.

Only originals will be accepted. Declarations of loss or theft and photocopies will not be accepted.

Technical check:

Motorcycles must be equipped with an adjustable stand or a removable side stand, for technical checks and for Parc Fermé.

The following points will be checked during the technical checks:

- Make, Model and Engine capacity
- Sound Test
- Cut Off Switch
- Self Closing Throttle
- Silencer
- Guard for the Countershaft Sprocket and rear Sprocket
- Handlebar Ends, protection and levers















- Tyres
- Helmets
- Protective Clothing

Transponders will also be fitted to vehicles and helmets.

Back and Chest Protectors

It is compulsory that riders wear a back and chest protector certified according to the international norm:

- EN 1621-2, Level 1 or 2, only CB (Central Back) or FB (Full Back)
- EN 1621-3, Level 1 or 2, for the chest;

Use of a functional airbag system is allowed. Its use must be declared during the Technical Verifications to the FIM Technical Director. The proper use of this device always remains under the responsibility of the rider.

The neck-brace is not compatible with the airbag and therefore is prohibited if the rider is using an airbag.

Helmets

A helmet is made to provide protection. A helmet is not a platform to attach foreign objects. Cameras or other accessories are NOT permitted nor shall be attached to the rider's helmet.

Sound Test:

Sound Test will be performed according to FIM Sound Regulations 2025.

At the FIM Sand Races World Cup, the maximum sound limit is 114.0 db/A before the race.

During and after the race is 115.0 db/A.

All tolerances are included in the maximum values.

An on-board camera is not allowed during the entire event, from the practice sessions until the end of the event.

5.1 BIBS AND PLATES

The Race bib, and the plates with the race numbers will be provided by the organizer in the Administrative Checks.

Numbers and background colours provided by the organisers will be in accordance with the FIM Sand Races World Championship Regulations, Art. 4.2, and the Art. 01.55 of the FIM Sand Races World Championship Technical Regulations:

9 RACE ORGANIZATION

The starts will take place on the beach of Monte Gordo, at low tide, and the circuit takes place on dry sand, and is about 6 km long.

Lines of 10 pilots will be made. The position in the starting "grid" depends on the classification in the World Cup, the driver's record, and the order of registration in the race. For the second race on the 30th, the 10 motorbike riders and 5 quad riders who make up the first row of the starting grid published on Sportity can choose their position on the line, with priority going to the first-placed rider and so on, and access to the circuit will be in the order of the published grid.

Access to the service area (ZA) or refuelling area (GAS) during the heats is possible through the defined route and a maximum speed of 30km/h. The return to the circuit is made by the same route in reverse direction (see Layout).

In the GAS zone, refueling or any other intervention on the vehicle is possible as long as no generators or welding machines are used.















<u>Refuelling*:</u> If necessary, the riders can go to the GAS area, using the accesses defined for this purpose (see Layout) to access the GAS and return to the circuit. During refuelling, the following safety standards must be followed:

- Turn off the vehicle's engine
- The pilot must leave the vehicle during fuelling
- One of the team members must be in possession of a fire extinguisher and accompany the process
- In GAS area the maximum speed allowed is 30km/h

*Also refer to Art. 15. SERVICE AREA (ZA) / REFUELLING (GAS) / SIGNHOLDER ZONE (ZS) & Art. 21. OTHER INFORMATION below.
There will be two races:

Duration of races:

- MOTO (classes M): 1h30m
- QUAD (classes Q): 1h00m
- MOTO (classes MJ): 45 minutes
- VINTAGE MOTORCYCLES (classes V): 45 minutes

Sunday 30th

- MOTO (classes M): 1h00m
- QUAD (classes Q): 45 minutes
- MOTO (classes MJ): 30 minutes
- VINTAGE MOTORCYCLES (classes V): 30 minutes

CIRCUIT AND RECONNAISSANCE

The Monte Gordo Sand Experience Circuit is 6 km long for the motorcycles and quads. The circuit reconnaissance is possible, only on foot, on the 28th between 10am and 4pm.

10 TIMEKEEPING

Transponders will be placed on the vehicle that will be used to count laps and time, when passing through the timing line.

Timekeepers count the number of laps completed by each participant. The final classification is calculated with the number of complete laps and the order of arrival at the finish line.

11 END OF THE RACE

Except in exceptional circumstances, the race ends when the first classified passes the finish line at the end of the time.

After each race, the first 5 vehicles classified of each category must go to the Parc fermé. Refer to Art. 6.1. Parc fermé on the arrival of the FIM Sand Races World Cup <u>Sporting</u> Regulations.

After the end, the pilot must return to the service area (ZA) using the route defined for this purpose and which also coincides with the access to the starts.















After the race, rider must return to the ZA through the beach.

ACCESS TO the seafront promenade with a racing motorcycle is strictly forbidden.

12 ENVIRONMENT

Riders are requested to strictly respect the FIM Environmental Code and FIM Sand Races World Cup Regulations.

- Tear-off films for goggles are strictly forbidden.
- Riders leaving waste in the public area will be penalised.
- Use of the environmental mat is obligatory as per Art. 4.1 of the FIM

Environmental Code.

13 SERVICE AREA (ZA) / REFFUELING (GAS) / SIGNHOLDER (ZS)

Location of the Service Area (ZA) and Refueling (GAS) in Monte Gordo: N 37º 10.706' W 07º 27.444'

Service Area (ZA)

The organisation has made a space available near the refuelling area and the circuit for the assistance vehicles to park. Access to this space is exclusive to vehicles bearing the accreditation sticker, one per rider.

Mandatory safety equipment:

- Fire extinguisher and stand mat in compliance with FIM Regulations
- Environmental mat

Speed limit in the area is 30km/h (controlled by a radar). Speeding will be penalised by a time or financial fine upon decision of the Clerk of the Course.

Refuelling Area (GAS)

During the races, refuelling must be carried out in a space created for this purpose, close to the Service **Area** and with access from the circuit. This space is **3x3** metres per **competitor.**

Only those carrying 'SERVICE' bracelets can access this space.

The following equipment must be placed in the space:

- Fire extinguisher and stand mat in compliance with FIM Regulations
- Environmental mat
- Fuel tanks with a maximum capacity of 22 litres for guads
- Fuel tanks with a maximum capacity of 12 litres for Motorcycles

Speed limit in the area is 30km/h (controlled by a radar). Speeding will be penalised by a time or financial fine upon decision of the Clerk of the Course. Riders must mark their number on their stand/tent/space.

Signalling zones (ZS)

A Signalling Zone (ZS) will be created next to the circuit (see Layout), the only place where information can be provided to the pilots, in addition to the following:

- It is allowed to change goggles in the ZS
- It is allowed to rest in the ZS and the provision of non-alcoholic beverages
- It is allowed to provide time information on site















- Maximum speed on site is 30km/h
- Access limited to people with bracelet

Any other intervention on the motorcycle at this location implies a penalty at the discretion of the race jury.

14 ADVERTISING

Race bibs and plates must not be cut or modified.

Riders who cover, cut and/or modify organiser advertising (plate and race bib) will not be authorised to start the race.

Race bibs and plates will be checked by stewards at the entrance to the rider's area.

If infringement is observed after the start of the race, the participant will receive a €1,000 fine.

Official race bibs must be worn and visible during the whole race including for ceremonies: podium, finish-line press conference etc.

If a participant's race bib is not completely visible during ceremonies, his finish-line bonus (gifts) will be cancelled.

Riders who wish to add elements of the official race bib on their personal jersey must respect the specifications for position, colour and dimensions provided by the organisers. Proofs must be sent for approval before printing to: acpmotorsport@acp.pt

List of organiser advertising supports:

- 1. Front plate compulsory
- 2. 2 side plates compulsory.
- 3. Race bib compulsory.

Any promotional, advertising or public relations operation of any nature during or referring to the race, including the use of films, videos and photos for commercial or similar purposes requires previous written authorisation from the organiser and is subject to duties payable to the organiser and prosecution.

Use of images by any means and on any media during the race is strictly forbidden, including for non-commercial use, without prior authorisation from the organiser. Noncompliance with this regulation will lead to legal proceedings.

Participants expressly accept that the organisation or delegated third-parties use and broadcast their image or images featuring them, photos, videos, TV programmes, on all medias and all by-products and by terrestrial and cable TV (cable, FTTx, ADSL), satellite, IPTV and on social media, mobile networks and any other means or media chosen by the Organiser such as VOD, Replay, regardless of the terminals used for viewing, standards allowing broadcast of still or moving images and the functionalities of any access control systems used.















Nor the Organisers nor FIM responsible for loss of on-board cameras or any other equipment on the circuit during the race.

15 CLASSIFICATION

The event final classifications will be established according to the Appendix IV of the FIM SAND RACES WORLD CUP.

Results: After the race

After validation by the FIM International Jury, Scratch Classification will be published on the Official Board and/or the official Sportity page

CIRCUIT SIGNS AND RESPECTIVE PENALTIES:

Several marshals' posts will be placed along the circuit with the aim of signalling places of crashes or accidents, using the following flags:

• **RED Flag** – Obligation for all runners to stop the race and go to the place indicated by the Officials.

(Any false start must be indicated by waving a red flag. The red flag has priority over all flags)

- BLACK flag and sign with the rider's number Obligation for the rider in question to stop the race and leave the circuit via the pit lane or by accessing the circuit to the paddock (ZA).
- YELLOW Flag, Fixed Danger, drive carefully.

(A fixed yellow flag will be displayed for a maximum of 5 minutes at the start of the first free practice session and during the sighting lap preceding a qualifying race or a race)

• **BLUE FLAG, Waved** – Be careful, you will be overtaken by a rider who is one lap ahead. Keep your course.

(The blue flag must be used by additional and specialised Track Marshals for this flag only. A fixed blue flag will be displayed during the sighting lap preceding a qualifying run or race).

• **MEDICAL flag, WHITE colour** – Medical personnel on the track; drive with extreme caution. Riders must ride each jump individually without overtaking until they have passed the area of concern.

(A medical flag must be available at each Track Marshal post. The medical flag has priority over the fixed and waved yellow flags)















• **GREEN Flag** – In the event of a combined session of Free Practice and Timed Practice: start of Timed Practice. In the case of a Race: free track for the start of the race.

(The green flag can only be used by an Official specialised for this flag only)

• **BLACK and WHITE checkered flag** – Finish of training, qualifying, warm-up and race.

STARTING PROCEDURES:

Riders must place themselves in the line indicated in the published starting list, for this purpose plates with each line number will be placed on the left side of the starting grid.

The lines will have 10 riders side by side.

A sign with the number 5 will be shown (informs that there are 5 minutes left for the start), another sign with the number 1 (1 minute left for the start), the pilots must start the engine.

30 seconds before the start, a sign with the number 30 will be shown given by dropping a GREEN or ACP Flag, which is raised when there are 10 seconds left to the start.

A false start will be penalized with 2 laps, which will be added to the laps performed by the driver in question.

ARRIVAL PROCEDURES:

The Checkered flag will be shown to the 1st place finisher when the race time has been exceeded and when they pass the timing line. Immediately after the finish, the winner of the race must stop at a specific place to make a statement to journalists. The rider who records the most laps in the shortest time wins.

In races involving the M, MJ, and V categories, the MJ and V riders finish 45 **or 30** minutes after the start. To this end, and in order not to influence the race of the others (1h30m **or 1h00m**), a specific display will be installed with the 45 **or 30** minutes countdown and the track stewards will signal drivers to leave the circuit for the ZA.

TIRES:

Any type of tire (enduro, baja, motocross) will be allowed as long as it does not exceed 19.5mm.

STOP AND GO:

In the case of non-compliance with certain points of the Regulations, the "stop and go" procedure may be applied, as decided by the Race Director. The rider **must stop** in the signaling zone (ZS) for a period of one minute.

By order of the Clerck of the Course, the person in charge of the stop and go will display the number of the sanctioned rider next to the timing and finish line area, who will then have a maximum of 3 laps to stop at the stop and go. If the stop and go is displayed in the last 3 laps, the rider must stop before the checkered flag is displayed. Otherwise, a time penalty will be applied by the Clerck of the Course.



- 2 mobile posts in a 4x4 vehicle, made up of 1 doctor and 1 nurse
- 1 Advanced Medical Post (AMP) on the perimeter of the circuit with a médical team, advanced life support equipment and a Type B vehicle
- 1 4x4 vehicle, Type C, with evacuation equipment

Security means:

- 1 Command Post (CP)
- 38 track stewards' posts consisting of 2 people each, 1 radio, 1 fire extinguisher and flags for signaling
- 3 vehicle rescue teams equipped with 4x4 vehicles
- 3 circuit cleaning teams with sand collection equipment
- 2 radio channels, one for stewards and rescue teams and the other for medical resources















Appendix V INSURANCE



FIM Riders' insurance information

The rider's insurance policy set up by the FIM is a service for all the Federations that are part of the programme for the period from January 1, 2025 to December 31, 2025.

Who is covered:

- Riders with a FIM/CONU/NMFP/Training Camp licence issued by a Federation which is part of the FIM riders' insurance programme.
- Riders competing in MotoGP, Moto2, Moto3 and MotoE are not part of the FIM riders' insurance
 programme and must follow the guidelines of their respective Federation.
- Riders competing in a Cross-Country Rally must follow the guideline of the Rally organiser.

Validity of the insurance:

- For all events on the FIM/CONUs/NMFP Calendars with an International Manifestation Number (IMN) or a National Manifestation open to Foreign Participation Number (MNFP).
- · For racing activities included in the official programme of the event only!
- Travel to and from the event venue.

Scope of coverage:

In case of accident, the FIM riders' insurance programme would cover:

- Emergency Medical treatment on the event's place (subsidiary and complementary to any other insurances the rider may hold)
- Repatriation to the rider's country of residence (as declared on the FIM/CONU/NMFP/Training Camp licence extranet by the rider's FMN)
 Death and Disability (Riders with a FIM/CONU/NMFP/Training Camp licence issued by a Federation
- which has subscribed this benefit through the FIM program)

Coverage is provided only in the country (or countries) where the insured event takes place, which may be anywhere in the world including the insured's principal country of residence.

Please note that this is an EMERGENCY insurance and in order to avoid any problems please follow the correct procedure.

What to do?

Before departure:

- · Always check beforehand whether your personal health insurance card is still valid.
- For European citizens, please travel with your European Health insurance card.

In case of an Emergency Incident /Urgent medical assistance need:

- The FIM riders' insurance programme is only valid at FIM/CONU/MNFP events with a valid Number (IMN) or NMFP. If you are attending private test and/or non-event practice days, YOU WILL NOT BE COVERED by the FIM insurance.
- Always follow the instructions or you may no longer be covered by the FIM riders' insurance programme!
- Please ensure you agree upon any medical care or medical arrangements with the FIM insurer before taking any action whatsoever!



- Do not delay in contacting the emergency helpline. Make the call as soon as you can to advise of your accident!
- Do not change or leave the hospital, before contacting the emergency claims line, or the FIM insurance services may not be provided.
- Do not leave the country in which the incident occurred, before contacting the emergency claims line, or the FIM Insurance services may not be provided.
